2) **Preferred Plus Plan 550C:** (Not Available to Residents of New York). The Preferred Plus Plan includes a package of Non-Insurance Services plus insurance benefits including Program Cancellation and Interruption, Program Delay, Accident & Sickness Medical Expense, Baggage and Personal Effects, Baggage Delay, plus a Cancel For Any Reason benefit that allows you to cancel your Program for any reason up to 2 (two) days before your scheduled Departure Date of your program and you purchase this plan within 21 days of the date your initial payment or deposit for your program is received.

If You cancel Your Program for any reason not otherwise covered by this Plan, benefits will be paid 65% of the Prepaid, forfeited, non-refundable Payment or Deposits You paid for Your Program.

Please Note: The Cancel For Any Reason Benefit is applicable to all prepaid non-refundable insured program costs.
